

# Motoring Offences

## 1. MOTORING OFFENCES (SUMMARY OFFENCES)

We can advise you on a wide range of Road Traffic Offences. Where there is the possibility of having penalty points imposed on your licence, or you are facing the possibility of disqualification from driving, it is important to take advice at the earliest opportunity to ensure the appropriate steps have been taken and that your particular circumstances have been taken into account to give you the best chance to keep your licence and minimise the number of points you receive on your licence.

## 2. HOW MUCH WILL IT COST?

There are various ways we can help you concerning motoring offences. If you intend to plead guilty and we represent you at the first hearing the estimate would be £825 plus VAT (20%).

If you intend to plead not guilty then the costs will be charged at an hourly rate of £375 plus VAT (20%). We will estimate a budget between £1,650 - £2,750 plus travel time, expenses, and VAT (20%), assuming a single court appearance is needed. This estimate varies considerably depending on the nature of the case.

We provide a personalised service and aim to keep you updated throughout your case to help you understand the process and discuss with you the costs involved.

- Significant delays.

### 4. THE KEY STAGES OF YOUR MATTER
